

Ordinance #2015-1164

AN ORDINANCE AMENDING SCHEDULE "XX" OF
ORDINANCE NO. 500, KNOWN AS THE
TRAFFIC ORDINANCE, AS AMENDED

BE IT ORDAINED, by the Mayor and Council of the Borough of Manville, County of Somerset, and State of New Jersey, as follows:

Section 1. AMENDMENT OF SCHEDULE XX - EMERGENCY STREETS

Schedule XX of Ordinance number 500 is hereby amended to include the following under the stated designations:

Section 2. INCONSISTENCY

Should any provision of this Ordinance be inconsistent with the provisions of any prior Ordinances, the inconsistent provisions of said prior Ordinances are hereby repealed, but only to the extent of such inconsistencies.

Section 3. SEVERABILITY

In the event that any provision of this Ordinance, or the application of thereof to any person or circumstance is declared invalid by a court of competent jurisdiction, such Ordinance which may be given effect and to realize this intent, the provisions and application of this Ordinance are declared to be severable.

Section 4. PURPOSE OF CAPTIONS

Captions contained in this Ordinance have been inserted only for the purpose of facilitation reference to the various sections, and are not intended and shall not be utilized to construe the intent and meaning of the text of any section.

Section 5. EFFECTIVE DATE

This shall be effective immediately upon final adoption, approval and publication in accordance with law.
