

**ORDINANCE #2013-1136**

**AN ORDINANCE TO AMEND PORTIONS OF ORDINANCE NO. 396 ENTITLED "AN ORDINANCE TO PREVENT VICE, IMMORALITY, DRUNKENNESS AND DISORDERLY CONDUCT, TO PROMOTE AND PRESERVE THE PUBLIC PEACE, HEALTH, SAFETY AND GOOD ORDER IN THE BOROUGH OF MANVILLE, COUNTY OF SOMERSET, AND STATE OF NEW JERSEY"**

**WHEREAS** portions of Ordinance 396 have been preempted by the New Jersey Code of Criminal Justice (NJSA 2C:1-1 et. seq.) and by other laws of the State of New Jersey:

**BE IT ORDAINED** by the Mayor and Council of the Borough of Manville in the County of Somerset and State of New Jersey, that Ordinance No. 396 be amended as follows:

Sections

1,3,4,5,6,7,8,9,10,11,12,13,14,15,16,17,18,19,20,21,22,23,24,25,26,27,28,29,30,32,33,34, 35, 36, 37, 38, 40, and 41 are hereby DELETED

Section 31 is hereby amended to read:

No person shall discharge any firearm as same may be defined by NJSA 2C:39-1 into or upon any street or other public place or quasi public place, or into any cars, vehicles, or private property not his own.

Section 43 is hereby be amended to reflect a maximum fine of not more than Two Thousand (\$2000) dollars.

The following sections are added

Section 47: CONSTRUCTION

Where consistent with the context in which used in this ordinance, words importing the singular shall include the plural; words importing the plural shall include the singular; and words importing one gender shall include all other genders.

Section 48: PURPOSE OF CAPTIONS

Captions contained in this ordinance have been inserted only for the purpose of facilitating reference to the various sections, and are not intended and shall not be utilized to construe the intent and meaning of the text of any section.

**EFFECTIVE DATE**

This Ordinance shall take effect upon its adoption and publication according to law.
