

ORDINANCE #2012-1125

**AN ORDINANCE TO REPEAL ORDINANCE NO. 1995-848, and 2010-1101 REGULATING
AND LICENSING TAXICABS
WITHIN THE BOROUGH OF MANVILLE**

WHEREAS NJSA 48:16-1 et seq. the New Jersey state statute governing municipal licensing and regulation of taxicabs has recently been amended.

WHEREAS the Borough of Manville has issued no taxi cab licenses for the 2012 year and has received no applications for the 2013 year.

WHEREAS the Borough of Manville wishes to enact a revised and updated Ordinance in compliance with amended state statute and to issue future licenses in accordance therewith; and

WHEREAS the Borough of Manville does not wish to issue licenses until which time an updated ordinance has been adopted:

BE IT ORDAINED by the Mayor and Council of the Borough of Manville in the County of Somerset and State of New Jersey, that Ordinance No. 1995-848 and 2010-1101 be hereby REPEALED.

CONSTRUCTION

Where consistent with the context in which used in this ordinance, words importing the singular shall include the plural; words importing the plural shall include the singular; and words importing one gender shall include all other genders.

INCONSISTENCY

Should any provision of this ordinance be inconsistent with the provisions of any prior ordinances, the inconsistent provisions of said prior ordinances are hereby repealed, but only to the extent of such inconsistencies.

SEVERABILITY

In the event that any provision of this ordinance, or the application thereof to any person or circumstance is declared invalid by a court of competent jurisdiction, such declaration of invalidity shall not affect any other provision or application of this ordinance which may be given effect and, to realize this intent, the provisions and applications of this ordinance are declared to be severable.

PURPOSE OF CAPTIONS

Captions contained in this ordinance have been inserted only for the purpose of facilitating reference to the various sections, and are not intended and shall not be utilized to construe the intent and meaning of the text of any section.

EFFECTIVE DATE


This ordinance shall take effect immediately upon final adoption, approval and publication in accordance with the laws of the State of New Jersey.




