

ORDINANCE #2012-1117

AN ORDINANCE AMENDING COLLECTION SCHEDULES IN ORDINANCE 2008-1073 WHICH REGULATES THE COLLECTION AND DISPOSAL OF BULK TRASH ITEMS, GARBAGE, MUNICIPAL WASTE AND SOLID WASTE WITHIN THE BOROUGH OF MANVILLE

BE IT ORDAINED by the Mayor and Council of the Borough of Manville, in the County of Somerset and State of New Jersey, as follows:

SECTION 1. Purpose

The purpose of this Ordinance is to clarify how the collection schedules for collection from residential users and for bulk trash items may be amended.

SECTION 2. Collection Schedules

Section 8 of Ordinance 2008-1073 entitled "Collection Schedules" is hereby amended as follows:

A. Collection from residential users shall be in accordance with a schedule announced by the Borough of Manville. The schedule may be amended from time to time by resolution of the governing body.

B. The schedule for collection of bulk trash items, in accordance with Section 3 of Ordinance 2008-1073, may be amended from time to time by resolution of the governing body.

SECTION 3. Inconsistency

Should any provision of this ordinance be inconsistent with the provisions of any prior ordinances, the inconsistent provisions of said prior ordinances are hereby repealed, but only to the extent of such inconsistencies.

SECTION 4. Severability

In the event that any provision of this ordinance, or the application thereof to any person or circumstance is declared invalid by a court of competent jurisdiction, such declaration of invalidity shall not affect any other provision or application of this ordinance which may be given effect and, to realize this intent, the provisions and applications of this ordinance are declared to be severable.

SECTION 5. Purpose of Captions

Captions contained in this ordinance have been inserted only for the purpose of facilitating reference to the various sections, and are not intended and shall not be utilized to construe the intent and meaning of the text of any section.

SECTION 6. Effective Date

This ordinance shall take effect immediately upon final adoption, approval and publication in accordance with the laws of the State of New Jersey.
