

Ordinance #2011-1103

**AN ORDINANCE AMENDING SCHEDULES "I" AND "IV" OF
ORDINANCE NO. 500, KNOWN AS THE TRAFFIC
ORDINANCE, AS AMENDED**

BE IT ORDAINED by the Mayor and Council of the Borough of Manville in the County of Somerset and State of New Jersey, as follows:

SECTION 1. AMENDMENT OF SCHEDULE I- NO PARKING

Schedule I of Ordinance No. 500 is hereby amended to repeal the following under the stated designations:

<u>NAME OF STREET</u>	<u>TIME</u>	<u>SIDE</u>	<u>LOCATION</u>
William Street	Anytime	North	South Main Street to Gladys Avenue

Schedule I of Ordinance No. 500 is hereby amended to include the following under the stated designations:

<u>NAME OF STREET</u>	<u>TIME</u>	<u>SIDE</u>	<u>LOCATION</u>
William Street	Anytime	North	From a point 77' east of South Main Street in an easterly direction to westerly curbline of Gladys Avenue

SECTION 2. AMENDMENT OF SCHEDULE IV – LIMITED TIME PARKING

Schedule IV of Ordinance No. 500 is hereby amended to include the following under the stated designations:

<u>NAME OF STREET</u>	<u>TIME</u>	<u>LIMIT</u>	<u>SIDE</u>	<u>LOCATION</u>
William Street	Anytime	1 Hour	North	Between a point 35' east of South Main Street and 42' easterly there from for 2 marked parking stalls

SECTION 3. INCONSISTENCY

Should any provision of this ordinance be inconsistent with the provisions of any prior ordinances, the inconsistent provisions of said prior ordinances are hereby repealed, but only to the extent of such inconsistencies.

SECTION 4. SEVERABILITY

In the event that any provision of this ordinance, or the application of thereof to any person or circumstance is declared invalid by a court of competent jurisdiction, such declaration of invalidity shall not affect any other provision or application of this ordinance which may be given effect, and, and to realize this intent, the provisions and application of this ordinance are declared to be severable.

SECTION 5. PURPOSE OF CAPTIONS

Captions contained in this ordinance have been inserted only for the purpose of facilitation reference to the various sections, and are not intended and shall not be utilized to construe the intent and meaning of the text of any section.

SECTION 6. EFFECTIVE DATE

This shall be effective immediately upon final adoption, approval and publication in accordance with law.
