

Ordinance #2009-1079

AN ORDINANCE AMENDING ORDINANCE #2003-981
"RECONSTITUTING THE POLICE DEPARTMENT"
BY ADDING SECTION 2H, ENTITLED
"ENFORCEMENT OF SOMERSET COUNTY PARK COMMISSION
RULES AND REGULATIONS"

BE IT ORDAINED by the Mayor and Council of the Borough of Manville, County of Somerset, State of New Jersey, as follows:

1. Section II entitled, "General Duties" of Ordinance #2003-981, "Reconstituting the Police Department", adopted February 24, 2003, as heretofore supplemented and amended is hereby supplemented and amended by adding a new section thereto as follows:

II General Duties

H. Enforcement of Somerset County Park Commission Rules and Regulations.

1. The Somerset County Park Commission's Rules and Regulations governing real property situated in Somerset County which is under the jurisdiction of the Somerset County Park Commission is hereby adopted by reference as if fully set forth herein. Such Rules and Regulations may hereinafter be amended by the Somerset County Park Commission from time to time and those amendments are hereby adopted as if fully set forth herein.

2. The Police Department of the Borough of Manville is hereby empowered to enforce the Somerset County Park Commission's Rules and Regulations on behalf of the Somerset County Park Commission on real property situated in the Borough of Manville, Somerset County which is under the jurisdiction of the Somerset County Park Commission. In addition, the said Police are also empowered to enforce all Borough of Manville Ordinances on the said properties.

3. In the event that an ambiguity exists between a Borough of Manville Ordinance and a rule or regulation of the Somerset County Park Commission, that ambiguity will be resolved in the favor of the Borough of Manville. In the further event that a conflict exists relative to a Borough of Manville Ordinance and a rule or regulation of the Somerset County Park Commission, the rule or regulation shall take precedence.

This Ordinance shall take effect upon the final passage and publication according to law.
