

ORDINANCE #2008-1068

**AN ORDINANCE AUTHORIZING THE BOROUGH CLERK
TO GRANT BINGO AND RAFFLE LICENSES AND
TO EXECUTE SPECIAL LIQUOR LICENSE PERMIT APPLICATIONS**

BE IT ORDAINED by the Mayor and Council of the Borough of Manville, County of Somerset and State of New Jersey, as follows:

1.) The Borough Clerk is hereby authorized and delegated to approve or deny the granting of Raffle and Bingo licenses for events to be conducted in the Borough of Manville. **In reviewing the license applications, the Borough Clerk shall apply the standards set forth in the “Raffles Licensing Law” and the “Bingo Licensing Law”, whichever is applicable. In the event the Borough Clerk issues a denial of a raffle or bingo license, the applicant may reapply to the Borough Council seeking approval for the license.**

2.) The Borough Clerk is hereby authorized to execute Social Affair permit applications and Catering permit applications as required by N.J.S.A. 33:1-74 and N.J.A.C. 13:2-5.1.

3.) All ordinances or parts of ordinances or resolutions that are in conflict with the provisions of this Ordinance are repealed to the extent necessary.


4.) If any article, section, subsection, term or condition of this Ordinance is declared invalid or illegal for any reason, the balance of the Ordinance shall be deemed severable and shall remain in full force and effect.

5.) This Ordinance shall take effect after approval of the Mayor or in accordance with law, and publication and passage according to law.
