

ORDINANCE NO. 2008-1072

AN ORDINANCE ADOPTING THE RULES AND REGULATIONS OF THE SOMERSET COUNTY PARK COMMISSION AS TO A CERTAIN PIECE OF REAL PROPERTY DESCRIBED HEREIN

WHEREAS, the governing body of the Borough of Manville (hereinafter referred to as the "Borough") has entered into a License Agreement with the County of Somerset (hereinafter referred to as the "County") for the use of a certain real property known and designated as Lots 6 and 7 in Block 312 on the Tax Map of the Borough of Manville (the "Property") as a recreation area;

WHEREAS, the aforementioned License Agreement requires the Borough to adopt an ordinance codifying the Rules and Regulations of the Somerset County Park Commission, as they may affect the Property, and which Rules and Regulations may be amended from time to time; and

WHEREAS, wherever in the License Agreement there is a conflict between the License Agreement and the Rules and Regulations of the Somerset County Park Commission, the terms and provisions of the License Agreement shall control;


NOW THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Manville, County of Somerset, and State of New Jersey, as follows:

All those Rules and Regulations of the Somerset County Park Commission set forth in Exhibit A attached hereto are hereby incorporated into and made a part of the Ordinances of the Borough, and shall be applicable to the aforementioned Property only.

STATEMENT OF PURPOSE

The purpose of this Ordinance is to acknowledge the License Agreement with the County and acknowledge compliance with the Rules and Regulations of the Somerset County Park Commission, except where a conflict exists between the License Agreement and the Rules and Regulations of the Somerset County Park Commission, wherein the terms and provisions of the License Agreement will control.
