

Ordinance #2008-1064

AN ORDINANCE ADOPTING A NOTIFICATION  
OF CONSTRUCTION/DEMOLITION ACTIVITIES

**BE IT ORDAINED** by the Mayor and Council of the Borough of Manville in the County of Somerset and State of New Jersey as follows:

**Section 1. Purpose.**

The purpose of this article is to adopt a notification policy for Construction/Demolition Activities in the Borough of Manville.

**Section 2. Notification of Construction/Demolition**

A. At the time of issuance of any construction and/or demolition permit(s), where the permittee possesses twenty-one (21) or more cubic yards of construction and/or demolition waste materials, the Construction Official shall provide to the permittee written instruction on property disposal and recycling of the construction and/or demolition waste materials.

B. The Construction Official shall also furnish to the permittee a "Notification of Construction/Demolition Activity Form" (See Notification of Construction/Demolition Activities Form Attached hereto as **Schedule "A"**). The permittee shall complete and execute the form and transmit it via facsimile to the Somerset County Department of Health - CEHA OPERATIONS within forty-eight (48) hours of the issuance of a construction and/or demolition permit.

C. Violation of any provision of this Section shall be subject to the penalties imposed pursuant to Ordinance #2006-1027 - General Penalty Ordinance.

**Section 3. Inconsistency.**

Should any provision of this ordinance be inconsistent with the provisions of any prior ordinances, the inconsistent provisions of said prior ordinances are hereby repealed, but only to the extent of such inconsistencies.

**Section 4. Severability**


In the event that any provision of this ordinance, or the application thereof to any person or circumstance is declared invalid by a court of competent jurisdiction, such declaration of invalidity shall not affect any other provision or application of this ordinance which may be given effect, and, to realize this intent, the provisions and applications of this ordinance are declared to be severable.

**Section 5. Effective Date**

This ordinance shall be effective immediately upon final adoption, approval and

publication in accordance with law.
