

ORDINANCE NO. 2007-1048

AN ORDINANCE AMENDING THE FEE SCHEDULE CONTAINED IN ORDINANCE NO. 2001-965

BE IT ORDAINED by the Mayor and Council of the Borough of Manville in the County of Somerset and State of New Jersey, as follows:

SECTION 1.

The Fee Schedule contained in Section I of Ordinance No. 2001-965 is hereby amended as follows:

- a) A new subsection "M" is added to "SECTION #1 – BUILDING SUB-CODE" to read as follows:

"M. Certificate of Continued Occupancy for non-residential - \$50.00."

- b) A new subsection "E" is added to "SECTION #2 – PLUMBING SUB-CODE" to read as follows:

"D. Certificate of Continued Occupancy for non-residential - \$50.00."

- c) A new subsection "J" is added to "SECTION #3 – FIRE PROTECTION SUB-CODE" to read as follows:

"D. Certificate of Continued Occupancy for non-residential - \$50.00."

- d) A new subsection "F" is added to "SECTION #5 – ELECTRICAL SUB-CODE" to read as follows:

"F. Certificate of Continued Occupancy for non-residential - \$50.00."

- e) A new subsection "B" is added to "SECTION #6 – GENERAL" to read as follows:

"B. Certificate of Continued Occupancy for non-residential - \$25.00."

SECTION 2. CONSTRUCTION

Where consistent with the context in which used in this ordinance, words importing the singular shall include the plural; words importing the plural shall include the singular; and, words importing one gender shall include all other genders.

SECTION 3. INCONSISTENCY

Should any provision of this ordinance be inconsistent with the provisions of any prior ordinances, the inconsistent provisions of said prior ordinances are hereby repealed, but only to the extent of such inconsistencies.

SECTION 4. SEVERABILITY

In the event that any provision of this ordinance, or the application thereof to any

person or circumstance is declared invalid by a court of competent jurisdiction, such declaration of invalidity shall not affect any other provision or application of this ordinance which may be given effect, and, to realize this intent, the provisions and applications of this ordinance are declared to be severable.

SECTION 5. PURPOSE OF CAPTIONS

Captions contained in this ordinance have been inserted only for the purpose of facilitating reference to the various sections, and are not intended and shall not be utilized to construe the intent and meaning of the text of any section.

SECTION 6. EFFECTIVE DATE

This ordinance shall be effective immediately upon final adoption, approval and publication in accordance with law.

STATEMENT OF PURPOSE

The purpose of this Ordinance is to establish fees for Certificates of Continued Occupancy for non-residential structures.
