

## ORDINANCE NO. 2007-1049

### AN ORDINANCE AMENDING SCHEDULES "I" AND "V" OF ORDINANCE NO. 500, AS AMENDED

BE IT ORDAINED by the Mayor and Council of the Borough of Manville in the County of Somerset and State of New Jersey, as follows:

#### **SECTION 1. AMENDMENT OF SCHEDULE I**

Schedule I of Ordinance No. 500 is hereby amended to repeal the following under the stated designations:

<u>NAME OF STREET</u>	<u>TIME</u>	<u>SIDE</u>	<u>LOCATION</u>
Brooks Boulevard	Anytime	South	At North Main Street to North 15 <sup>th</sup> Avenue in a westerly Direction”

Schedule I of Ordinance No. 500 is hereby amended to include the following under the Stated designations:

<u>NAME OF STREET</u>	<u>TIME</u>	<u>SIDE</u>	<u>LOCATION</u>
Brooks Boulevard	Anytime	South	North Main Street to a point 75’ west the westerly curblineline of North 13 <sup>th</sup> Avenue

#### **SECTION 2. AMENDMENT OF SCHEDULE V**

Schedule V of Ordinance No. 500 is hereby amended to include the following under the Stated designations:

<u>NAME OF STREET</u>	<u>LOCATION</u>
Roosevelt Avenue	In a westerly direction from South Main Street to South 21st Avenue
South 5 <sup>th</sup> Avenue	From South Main Street to West Camplain Road
South 5 <sup>th</sup> Avenue	From West Camplain Road to South Main Street
Pope Street	From West Camplain Road to Roosevelt Avenue”

#### **SECTION 3. INCONSISTENCY**

Should any provision of this ordinance be inconsistent with the provisions of any prior ordinances, the inconsistent provisions of said prior ordinances are hereby repealed, but only to the extent of such inconsistencies.

**SECTION 4. SEVERABILITY**

In the event that any provision of this ordinance, or the application thereof to any person or circumstance is declared invalid by a court of competent jurisdiction, such declaration of invalidity shall not affect any other provision or application of this ordinance which may be given effect, and, to realize this intent, the provisions and applications of this ordinance are declared to be severable.

**SECTION 5. PURPOSE OF CAPTIONS**

Captions contained in this ordinance have been inserted only for the purpose of facilitating reference to the various sections, and are not intended and shall not be utilized to construe the intent and meaning of the text of any section.

**SECTION 6. EFFECTIVE DATE**

This shall be effective immediately upon final adoption, approval and publication in accordance with law.
