

ORDINANCE NO. 2007-1059

AN ORDINANCE REPEALING ARTICLE 6 ENTITLED "STORM WATER CONTROL" OF "THE LAND DEVELOPMENT ORDINANCE OF THE BOROUGH OF MANVILLE" AND INCORPORATING BY REFERENCE ORDINANCE NO. 2006-1031 ENTITLED "AN ORDINANCE OF THE BOROUGH OF MANVILLE, COUNTY OF SOMERSET, STATE OF NEW JERSEY, ESTABLISHING A STORMWATER MANAGEMENT PROGRAM," AS THE NEW ARTICLE 6 OF "THE LAND DEVELOPMENT ORDINANCE OF THE BOROUGH OF MANVILLE"

BE IT ORDAINED by the Mayor and Council of the Borough of Manville in the County of Somerset and State of New Jersey, as follows:

SECTION 1. REPEAL OF EXISTING ARTICLE 6

The currently existing Article 6 entitled " STORM WATER CONTROL" of "THE LAND DEVELOPMENT ORDINANCE OF THE BOROUGH OF MANVILLE" is hereby repealed.

SECTION 2. INCLUSION OF ORDINANCE NO 2006-1031 BY REFERENCE

Ordinance No 2006-1031 entitled "AN ORDINANCE OF THE BOROUGH OF MANVILLE, COUNTY OF SOMERSET, STATE OF NEW JERSEY, ESTABLISHING A STORMWATER MANAGEMENT PROGRAM," is hereby incorporated by reference as the new Article 6 of "THE LAND DEVELOPMENT ORDINANCE OF THE BOROUGH OF MANVILLE."

SECTION 3. CONSTRUCTION

Where consistent with the context in which used in this ordinance, words importing the singular shall include the plural; words importing the plural shall include the singular; and, words importing one gender shall include all other genders.

SECTION 4. INCONSISTENCY

Should any provision of this ordinance be inconsistent with the provisions of any prior ordinances, the inconsistent provisions of said prior ordinances are hereby repealed, but only to the extent of such inconsistencies.

SECTION 5. SEVERABILITY

In the event that any provision of this ordinance, or the application thereof to any person or circumstance is declared invalid by a court of competent jurisdiction, such declaration of invalidity shall not affect any other provision or application of this ordinance

which may be given effect, and, to realize this intent, the provisions and applications of this ordinance are declared to be severable.

SECTION 6. PURPOSE OF CAPTIONS

Captions contained in this ordinance have been inserted only for the purpose of facilitating reference to the various sections, and are not intended and shall not be utilized to construe the intent and meaning of the text of any section.


SECTION 7. EFFECTIVE DATE
