

ORDINANCE NO. 2006-1033

AN ORDINANCE AMENDING SECTION 6-1 AND SCHEDULES II, V, AND X OF ORDINANCE NO. 500 AS AMENDED

BE IT ORDAINED by the Mayor and Council of the Borough of Manville in the County of Somerset and State of New Jersey, as follows:

SECTION 1. AMENDMENT OF SECTION 6-1

Section 6-1 of Ordinance No. 500 is hereby amended to read as follows:

"The locations listed in Schedule X are hereby designated as "Loading Zones." No person shall park a vehicle in any Loading Zone during the times indicated other than for the loading or unloading of goods and materials."

SECTION 2. AMENDMENT OF SCHEDULE II

Schedule II of Ordinance No. 500 is hereby amended to include the following under the stated designations:

<u>"NAME OF STREET</u>	<u>TIME</u>	<u>SIDE</u>	<u>LOCATION</u>
Newark Avenue	7:30 a.m. to 3:00 p.m. Monday through Friday (when school is in session)	South	Beginning at a point 50 feet east of the easterly curbline of Onka Avenue and extending to a point 300 feet easterly therefrom."

SECTION 3. AMENDMENT OF SCHEDULE V

Schedule V of Ordinance No. 500 is hereby amended to include the following under the stated designations:

<u>"NAME OF STREET</u>	<u>LOCATION</u>
South 6 th Avenue	From West Camplain Road to Roosevelt Avenue
South 7 th Avenue	From West Camplain Road to Roosevelt Avenue
South 8 th Avenue	From West Camplain Road to Roosevelt Avenue"

SECTION 4. AMENDMENT OF SCHEDULE X

<u>"NAME OF STREET</u>	<u>TIME</u>	<u>SIDE</u>	<u>LOCATION</u>
Newark Avenue	7:30 a.m. to 3:00 p.m. Monday through Friday (when school is in session)	North	Beginning at a point 50 feet east of the easterly curbline of Onka Avenue and extending to appooint 314 feet easterly therefrom."

SECTION 5. CONSTRUCTION

Where consistent with the context in which used in this ordinance, words importing the singular shall include the plural; words importing the plural shall include the singular; and, words importing one gender shall include all other genders.

SECTION 6. INCONSISTENCY

Should any provision of this ordinance be inconsistent with the provisions of any prior ordinances, the inconsistent provisions of said prior ordinances are hereby repealed, but only to the extent of such inconsistencies.

SECTION 7. SEVERABILITY

In the event that any provision of this ordinance, or the application thereof to any person or circumstance is declared invalid by a court of competent jurisdiction, such declaration of invalidity shall not affect any other provision or application of this ordinance which may be given effect, and, to realize this intent, the provisions and applications of this ordinance are declared to be severable.

SECTION 8. PURPOSE OF CAPTIONS

Captions contained in this ordinance have been inserted only for the purpose of facilitating reference to the various sections, and are not intended and shall not be utilized to construe the intent and meaning of the text of any section.

SECTION 9. EFFECTIVE DATE

This ordinance shall be effective immediately upon final adoption, approval and publication in accordance with law.
