

ORDINANCE NO. 2006-1045

AN ORDINANCE WAIVING CERTAIN MUNICIPAL FEES OR CHARGES FOR QUALIFIED VOLUNTEER MEMBERS OF THE MANVILLE FIRE DEPARTMENT AND MANVILLE RESCUE SQUAD.

BE IT ORDAINED by the Mayor and Council of the Borough of Manville in the County of Somerset and State of New Jersey, as follows:

SECTION 1. WAIVER OF FEES

All municipal fees or charges, excepting fees or charges for services performed by other than Borough employees, imposed in order to secure a construction permit for any construction, reconstruction, alteration or improvement of any one or two family home, owned by and in which a qualified Volunteer, as hereinafter defined, is or will be a full-time resident, shall be waived upon the filing of an appropriate application therefor. In order to be a qualified Volunteer, the following conditions must be satisfied:

- (1) The Volunteer must be a volunteer member of a Manville fire company or the Manville Rescue Squad for a minimum of one continuous year immediately preceding the date of the application for construction;
- (2) The Volunteer shall have served without remuneration or an agreement or contract for hire during the one year period;
- (3) The Volunteer shall have satisfied the requisite percentage of activity, attendance and participation of the fire company or rescue squad;
- (4) The chief executive officer of the fire company or rescue squad shall certify in writing that the Volunteer has satisfied the requirements of paragraphs (1) through (3), hereof; and
- (5) The Volunteer shall certify in writing that he satisfies the residency requirements of this subsection.

SECTION 2. CONSTRUCTION

Where consistent with the context in which used in this ordinance, words importing the singular shall include the plural; words importing the plural shall include the singular; and, words importing one gender shall include all other genders.

SECTION 3. INCONSISTENCY

Should any provision of this ordinance be inconsistent with the provisions of any prior ordinances, the inconsistent provisions of said prior ordinances are hereby repealed, but only to the extent of such inconsistencies.

SECTION 4. SEVERABILITY

In the event that any provision of this ordinance, or the application thereof to any person or circumstance is declared invalid by a court of competent jurisdiction, such declaration of invalidity shall not affect any other provision or application of this ordinance which may be given effect, and, to realize this intent, the provisions and applications of this ordinance are declared to be severable.

SECTION 5. PURPOSE OF CAPTIONS

Captions contained in this ordinance have been inserted only for the purpose of facilitating reference to the various sections, and are not intended and shall not be utilized to construe the intent and meaning of the text of any section.

SECTION 6. EFFECTIVE DATE

This ordinance shall be effective immediately upon final adoption, approval and publication in accordance with law.
