

ORDINANCE #2004-990

AN ORDINANCE ESTABLISHING THE POSITION OF PUBLIC SAFETY COORDINATOR

BE IT ORDAINED by the Mayor and Council of the Borough of Manville, in the County of Somerset and State of New Jersey, as follows:

SECTION 1. ESTABLISHMENT OF POSITION

The position of Public Safety Coordinator is hereby established under the administrative supervision of the Chief of Police. The Public Safety Coordinator shall serve as the liaison for the Borough between the Borough's Office of Emergency Management and: the Police Department, Fire Department, and Rescue Squad.

SECTION 2. DUTIES

The duties of the Public Safety Coordinator shall include:

1. Attendance at meetings of the Somerset County Office of Emergency Management and the obtaining of all relevant information for the Borough;
2. Responsibility for obtaining grant information for the Borough's Office of Emergency Management;
3. Transmittal of all relevant information to the Police, Fire, Rescue and Office of Emergency Management agencies within the Borough;
4. Collaboration with Homeland Security plans, programs and operations within the Borough;
5. Involvement, as directed, with the obtaining of equipment; and
6. Such other and further associated duties as may be required by the Chief of Police.

SECTION 3. TERM OF OFFICE

The Public Safety Coordinator shall be appointed by the Mayor with the advice and consent of the Council, for a term of three (3) years commencing as of January 1. The initial term of the first appointee shall expire on December 31, 2006, or until his successor is appointed and qualified. Vacancies in office shall be filled for the balance of the unexpired term.

SECTION 4. COMPENSATION

The Public Safety Coordinator shall receive an annual salary of \$1,500.00.

SECTION 5. INCONSISTENCY

Should any provision of this ordinance be inconsistent with the provisions of any prior ordinances, the inconsistent provisions of said prior ordinances are hereby repealed, but only to the extent of such inconsistencies.

SECTION 6. SEVERABILITY

In the event that any provision of this ordinance, or the application thereof to any person or circumstance is declared invalid by a court of competent jurisdiction, such declaration of invalidity shall not affect any other provision or application of this ordinance which may be given effect, and, to realize this intent, the provisions and applications of this ordinance are declared to be severable.

SECTION 7. PURPOSE OF CAPTIONS

Captions contained in this ordinance have been inserted only for the purpose of facilitating reference to the various sections, and are not intended and shall not be utilized to construe the intent and meaning of the text of any section.

SECTION 8. EFFECTIVE DATE

This ordinance shall be effective immediately upon final adoption, approval and publication in accordance with law.
