

ORDINANCE # 2000-939

“AN ORDINANCE TO PROVIDE FOR AND DETERMINE THE ANNUAL RATES OF COMPENSATION OF CERTAIN OFFICERS AND EMPLOYEES OF THE BOROUGH OF MANVILLE, COUNTY OF SOMERSET, STATE OF NEW JERSEY.

BE IT ORDAINED, by the Mayor and Council of the Borough Manville, County of Somerset, State of New Jersey as follows:

- 1) The maximum annual rates of compensation for the officers and employees listed are hereby established as follows:

- 3) In the event that any provision of this Ordinance, or the application thereof to any person or circumstance is declared invalid by a court of competent jurisdiction, such declaration of invalidity shall not affect any other provision or application of this ordinance which may be given effect, and, to realize this intent, the provisions and application of this ordinance are declared to be severable.
- 4) Except as may be specifically set forth in this Ordinance, any and all other salary ordinances are hereby repealed.
- 5) This ordinance shall be effective immediately upon final approval and publication in accordance with the law.
