

ORDINANCE #2000-944

ORDINANCE ESTABLISHING A JUNIOR FIREFIGHTER
PROGRAM WITHIN THE FIRE DEPARTMENT

BE IT ORDAINED by the Mayor and Council of the Borough of Manville, in the County of Somerset and State of New Jersey, as follows:

1. The Fire Department may organize, maintain, operate and administer a program known as the "Manville Fire Department Junior Firefighter Program", to be supervised by one active firefighter selected by the Chief and the line officers of the Manville Fire Department Board of Engineers, for the purpose of allowing young men and women between the ages of 14 and 17 to participate in designated firefighting duties and activities. The Fire Department shall promulgate rules and regulations and amendments and supplements thereto for the government, maintenance, regulation and control of the Junior Firefighting Program and the discipline of its members. Any such rules and regulations and any amendments and supplements thereto shall, prior to becoming effective, be approved by resolution of the Mayor and Council. Such rules and regulations shall be contained in a manual entitled the "Manville Fire Department Junior Firefighters Rules and Regulations" and a copy of such rules and regulations shall be kept in the office of the Borough Clerk.

2. Where consistent with the context in which used in this Ordinance, words importing the singular shall include the plural; words importing the plural shall include the singular; and words importing one gender shall include all other genders.

3. Should any provision of this Ordinance be inconsistent with the provisions of any prior Ordinances, the inconsistent provisions of said prior Ordinances are hereby repealed, but only to the extent of such inconsistencies.

4. In the event that any provision of this Ordinance, or the application thereof to any person or circumstance is declared invalid by a court of competent jurisdiction, such declaration of invalidity shall not affect any other provision or application of this Ordinance which may be given effect, and to realize this intent, the provisions and applications of this Ordinance are declared to be severable.

5. This Ordinance shall be effective immediately upon final adoption, approval and publication in accordance with law.
