

ORDINANCE #2000-948

**AN ORDINANCE AMENDING THAT PROVISION OF SCHEDULE II OF
ORDINANCE #500 RELATING TO NORTH 5TH AVENUE, AS
AMENDED BY ORDINANCE #94-800; AND ESTABLISHING HANDICAPPED
PARKING SPACES ON NORTH 5TH AVENUE**

BE IT ORDAINED by the Mayor and Council of the Borough of Manville, in the County of Somerset and State of New Jersey, as follows:

1. That provision of Schedule II of Ordinance No. 500 relating to North 5th Avenue, as amended by Ordinance No. 94-800, is hereby further amended to read under the headings indicated as follows:

<u>NAME OF STREET</u>	<u>SIDES</u>	<u>HOURS</u>	<u>LOCATION</u>
"North 5 th Avenue	East	8 a.m. to 4 p.m.	Between the northerly curblineline of Brooks Boulevard and a point 311 feet north thereof"

2. The following described location is hereby designated as an area of restricted parking spaces pursuant to N.J.S.A. 39:4-197.5. No person shall park in said spaces except in conformity with the restrictions of applicable statutes.

<u>NAME OF STREET</u>	<u>SIDES</u>	<u>LOCATION</u>
North 5 th Avenue feet	East	Beginning at a point 311 north of the northerly curb- line of Brooks Boulevard and extending to a point 44 feet north thereof

3. Where consistent with the context in which used in this Ordinance, words importing the singular shall include the plural; words importing the plural shall include the singular; and, words importing one gender shall include all other genders.

4. Should any provision of this Ordinance be inconsistent with the provisions of any prior Ordinances, the inconsistent provisions of said prior Ordinances are hereby repealed, but only to the extent of such inconsistencies.

5. In the event that any provision of this Ordinance, or the application thereof to any person or circumstance is declared invalid by a court of competent jurisdiction, such declaration of invalidity shall not affect any other provision or application of this Ordinance which may be given effect, and, to realize this intent, the provisions and applications of this Ordinance are declared to be severable.

6. Any person convicted of violation of any provision of this Ordinance shall be subject to such penalty as shall be expressly provided by New Jersey statute, or in the absence of any such specified penalty, a penalty in accordance with Ordinance No. 97-887.

7. This Ordinance shall be effective immediately upon final adoption, approval and publication in accordance with law, provided, however, the provisions of Section 2 shall not be enforced until appropriate signs shall have been placed pursuant to N.J.S.A. 39:4-198.
