Ordinance #2022 -1286

An Ordinance To Amend Ordinance No. 500, Known As The Traffic Ordinance, As Amended

Statement of Purpose

An ordinance amending Ordinance No. 500 which amends “no parking on certain streets because of snow” to now include no parking on all streets because of snow in the Borough of Manville.

BE IT ORDAINED by the Mayor and Council of the Borough of Manville in the County of Somerset and State of New Jersey, as follows:

SECTION 1. AMENDMENT OF SECTION 11-1 NO PARKING ON STREETS DURING A SNOW EMERGENCY TO ADD A NEW SECTION 11-1-[2] TO READ AS FOLLOWS

11-1-[2](A) Whenever a snow emergency has been declared by the Governor or the Borough Office of Emergency Management Coordinator, no vehicle shall be parked on any roadway or street in the Borough.:

11-1-[2] (B) This street parking prohibition shall remain in effect until the snow has ceased and until the streets have been plowed sufficiently and to the extent that parking will not interfere with the normal flow of traffic; or until such time as the Snow Emergency has been lifted.

11-1-[2](C) During the period of this street parking prohibition, any Borough ordinance restricting parking on a property to driveways or parking areas shall be temporarily suspended until the streets have been plowed sufficiently and to the extent that street parking will not interfere with the normal flow of traffic; or until such time as the Snow Emergency has been lifted.

SECTION 2. INCONSISTENCY

Should any provision of this ordinance be inconsistent with the provisions of any prior ordinances, the inconsistent provisions of said prior ordinances are hereby repealed, but only to the extent of such inconsistencies.

SECTION 3. SEVERABILITY

In the event that any provision of this ordinance, or the application of thereof to any person or circumstance is declared invalid by a court of competent jurisdiction, such declaration of invalidity shall not affect any other provision or application of this ordinance which may be given effect, and, to realize this intent, the provisions and application of this ordinance are declared to be severable.

SECTION 4. PURPOSE OF CAPTIONS

Captions contained in this ordinance have been inserted only for the purpose of facilitation reference to the various section, and are not intended and shall not be utilized to construe the intent and meaning of the text of any section.

SECTION 5. EFFECTIVE DATE

This ordinance shall be effective immediately upon final adoption, approval, and publication in accordance with law.
