Resolution #2024-27

Authorizing Agreement with Taylor Wiseman Taylor for Professional Services as Flood Plain Management Consultant, Flood Hazard Mitigation Consultant, and Flood Community Rating System (CRS) Consultant, through December 31, 2024

WHEREAS, the governing body of the Borough of Manville appointed Taylor Wiseman Taylor as Flood Plain Management Consultant for 2024, at its January 6, 2024 Meeting; and

WHEREAS, the Local Public Contracts Law (N.J.S.A. 40A:11-1, et seq.) requires that the resolution authorizing the award of contracts for "professional services" without competitive bids on the contract itself must be available for public inspection; and

WHEREAS, the governing body, upon review of qualifications, determined that Taylor Wiseman Taylor has the necessary qualifications to perform the duties of Borough Flood Plain Management Consultant, Flood Hazard Mitigation Consultant, and Flood Community Rating System (CRS) Consultant, and has provided the Borough with a satisfactory proposal; and

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Manville, County of Somerset, State of New Jersey, as follows:

1) The proposed Professional Services Agreement, for the period January 1, 2024 through December 31, 2024, from Taylor Wiseman Taylor in the form provided and incorporated herein by reference, is accepted.

2) This contract is awarded without competitive bidding as a "Professional Service" in accordance with N.J.S.A 40:11-5(1)(a) of the Local Public Contracts Law;

3) The Mayor, Borough Chief Financial Officer, or Borough Administrator are hereby authorized to execute the proposed Professional Services Agreement, as consistent with the

terms of this Resolution, and, without further resolution of the governing body, not to exceed \$39,000 for Flood Plain Management Consultant matters, \$13,000 for Flood Community Rating System (CRS) Consultant matters and \$21,000 for Flood Hazard Mitigation matters.

4) A Notice of award of this contract shall be published once, in accord with N.J.S.A §40:11-5(1)(a)(i).

5) The Chief Financial Officer shall provide a Certification of Funds.
