**A Resolution By The Mayor & Council Of The Borough Of Manville
Authorizing The Appointment Of A Borough DPW Director**

WHEREAS, the need exists within the Borough of Manville for one appointments of a Department of Public Works (DPW) Director; and

WHEREAS, after interviewing and screening, the Mayor, Policy, Planning, and Personnel Committee of the Council, and Borough Administrator have recommended that Mr. George M. Watkins be appointed to the position of Borough DPW Director; and

WHEREAS, the Mayor and Council agree that said appointment is in the best interest of the Borough of Manville,

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Manville, County of Somerset, and State of New Jersey, as follows:

- (1) George M. Watkins is hereby appointed to the position of Borough DPW Director, at the initial annual salary of \$95,000, effective immediately upon passage of this Resolution and Mr. Watkins' assumption of his duties. Upon successful completion of successful probationary period, Mr. Watkins shall receive a one-time \$3000 boost to his salary upon successful completion of the CPWM certification and will receive an increase of \$5,000 (to \$100,000 per annum) for calendar year 2025 and will receive an increase of \$5,000 (to \$105,000 per annum) for calendar year 2026. Any subsequent changes in compensation, after December 31, 2026, will be subject to further resolutions of the Mayor & Council.
- (2) The terms and conditions of Mr. Watkins' employment shall be in accord with State law and as set forth in Ordinance #2023-1289 and the Memorandum of Employment attached to and a made a part of this Resolution.
- (3) The Mayor is hereby authorized to sign and execute said Memorandum of Employment on behalf of the Borough.
- (4) This Resolution shall be construed in accordance with the Ordinances of the Borough of Manville, the Laws of the State of New Jersey, and the Laws of the United States.
- (5) This Resolution shall take effect immediately upon enactment of same.
