**A Resolution By The Mayor & Council Of The Borough Of Manville
Authorizing The Appointment Of A Borough Municipal Clerk/Vital Statistics [BOH Secretary/Registrar]**

WHEREAS, the need exists within the Borough of Manville for one appointments of a Municipal Clerk;
and

WHEREAS, after interviewing and screening, the Mayor, Policy, Planning, and Personnel Committee of the Council, and Borough Administrator have recommended that Mr. William C. Bray be appointed to the position of Borough Municipal Clerk/Vital Statistics [Registrar/BOH Secretary]; and

WHEREAS, the Mayor and Council agree that said appointment is in the best interest of the Borough of Manville,

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Manville, County of Somerset, and State of New Jersey, as follows:

- (1) William C. Bray is hereby appointed to the position of Borough Clerk/Vital Statistics, at the initial annual pensionable salary of \$80,000; and \$10,000 stipend for Registrar/BOH Secretary effective immediately upon passage of this Resolution and Mr. Bray's assumption of his duties., will be subject to further resolutions of the Mayor & Council.
- (2) The terms and conditions of Mr. Bray's employment shall be in accord with State law and as set forth in Ordinance #2023-1289 & 2023-1298 and the Memorandum of Employment attached to and a made a part of this Resolution.
- (3) The Mayor is hereby authorized to sign and execute said Memorandum of Employment on behalf of the Borough.
- (4) This Resolution shall be construed in accordance with the Ordinances of the Borough of Manville, the Laws of the State of New Jersey, and the Laws of the United States.
- (5) This Resolution shall take effect immediately upon enactment of same.
