**WHEREAS**, on April 2, 2024, one bid was received from Zodiac of North America, Inc. of 540 Thopson Creek Rd., Stevensville, MD 21660, in the amount of \$127,000.00; and

**WHEREAS**, pursuant to NJSA and 40A:11-13.2 (a) the Borough Council is authorized to reject all bids; and

**WHEREAS**, the Borough Council has determined that it is in the best interest of the Borough to re-bid for Aluminum/Fiberglass Rigid Inflatable Rescue Boat.
