**An Ordinance to Amend An Ordinance 98-911 Entitled" An Ordinance to Amend an
Ordinance Entitled "An Ordinance Concerning Alcoholic Beverages"**

Statement of Purpose

The purpose of this section is to Amend Ordinance #98-911, by establishing new schedule of Liquor License Fees within the Borough of Manville, New Jersey.

Be It Ordained By The Mayor And Council Of The Borough Of Manville, in the County Of Somerset And State Of New Jersey as follows:

1) Section I of Ordinance No. 98-911 is amended to read:

SECTION I. That Section 8 (a) of an ordinance entitled "An Ordinance Concerning Alcoholic Beverages" is amended to read as follows:

(a) Plenary retail consumption license shall be:

\$1,296.00 for license year July 1, 2024 to June 30, 2025.

\$1,555.20 for license year July 1, 2025 to June 30, 2026.

\$1,866.24 for license year July 1, 2026 to June 30, 2027.

\$2,239.49 for license year July 1, 2027 to June 30, 2028.

\$2,500.00 for license year July 1, 2028 to June 30, 2029 and thereafter, unless until amended by subsequent ordinance of the Borough of Manville.

SECTION II.

That Section 8(b) of an ordinance entitled "An Ordinance Concerning Alcoholic Beverages" is amended to read as follows:

(b) Plenary retail distribution license shall be:

\$708.00 for license year July 1, 2024 to June 30, 2025.

\$849.60 for license year July 1, 2025 to June 30, 2026.

\$1,019.52 for license year July 1, 2026 to June 30, 2027.

\$1,223.42 for license year July 1, 2027 to June 30, 2028.

\$1,468.11 for license year July 1, 2028 to June 30, 2029.

\$1,761.73 for license year July 1, 2029 to June 30, 2030.

\$2,114.08 for license year July 1, 2030 to June 30, 2031

\$2,500.00 for license year July 1, 2031 to June 30, 2032 and thereafter, unless until amended by subsequent ordinance of the Borough of Manville.

SECTION 3: Severability. In the event that any provision of this Ordinance, or the application thereof to any person or circumstance is declared invalid by a court of competent jurisdiction, such declaration of invalidity shall not affect any other provision or application of this ordinance which may be given effect, and, to realize this intent, the provisions and applications of this ordinance are declared to be severable.

SECTION 4: Repealer. Should there exist any inconsistency with other ordinances of the Borough, or should any provision of this ordinance be inconsistent with the provisions of any other prior ordinances, the inconsistent provisions of such other prior ordinances are hereby repealed, but only to the extent of such inconsistencies.

SECTION 5: Purpose of Captions. The captions contained in this Ordinance have been inserted only for the purpose of facilitation reference to the various sections, and are not intended and shall not be utilized to construe the intent and meaning of the text of any section.

SECTION 6: Effective Date. This Ordinance shall take effect after adoption, passage, and publication according to law.
