Resolution Rejecting the Re-Bid for Rescue Boat and
Authorizing Negotiations for a Rescue Boat

WHEREAS, a request for re-bids for an Aluminum/Fiberglass Rigid Inflatable Rescue Boat was issued, as described in Bid No. 02-2024; and

WHEREAS, after the required legal advertisement was published, sealed bids were received at the Borough Hall on May 08, 2024 at 12:00 PM.

WHEREAS, two bid was received within the stipulated timeframe; and

WHEREAS, that bids were:

1. Zodiac of North America Inc., 540 Thompson Creek Rd, Stevensville, MD 21666 in the amount of \$83,000; and
2. Fluid Boats, 91 Volks Way, Franklinton NC, 27525 in the amount of \$89,302.74; and

WHEREAS, upon review and evaluation of the bids submitted, it has been determined that the proposed prices exceed the allocated budget for this project; and

WHEREAS, the Governing Body recognizes the importance of prudent financial management and adherence to budgetary constraints while ensuring the highest standards of quality and value for taxpayers; and

WHEREAS, considering the bids received and its pricing exceeding the budgetary provisions, the Governing Body finds it necessary to reject the bid in accordance with the relevant procurement regulations; and

WHEREAS, the Governing Body recognizes that there is still in need of a rescue Boat; and

WHEREAS, the Governing Body has gone out to bid unsuccessfully twice for a Aluminum/Fiberglass Rigid Inflatable Rescue Boat, authorizes the Police Department to receive quotes for a Rescue Boat;

NOW, THEREFORE BE IT RESOLVED, by the Borough Council of Manville Borough:

The bids submitted by Zodiac of North America and Fluid Boats for Bid No. 02-2024 are hereby rejected due to the proposed price exceeding the allocated budget, and negotiations are authorized.
