**AWARD CONTRACT FOR CDBG FUNDED MANVILLE LIBRARY IMPROVEMENTS**  
**(CIRCULATION DESK)**

**WHEREAS**, the Borough of Manville has determined a need for an Electrical Contractor to perform work for the CDBG Funded Manville Library Improvements (Circulation Desk) project; and

**WHEREAS**, the Borough of Manville solicited public bids for the project on March 6, 2024 and did not receive any submissions; and

**WHEREAS**, the Borough of Manville solicited public bids for the project on April 18, 2024 and received only one bid which was beyond the project budget and rejected; and

**WHEREAS**, the Borough of Manville adopted Res. 2024-111 to reject all bids and authorize negotiations with vendors for this project; and

**WHEREAS**, the Borough of Manville solicited quotes from Electrical contracts for the Manville Library Improvements (Circulation Desk); and

**WHEREAS**, the Borough of Manville received four written quotes with the lowest from R. P. L. Electrical Contractors LLC of Manville, NJ in the amount of \$4,250.00.

**NOW, THEREFORE, BE IT RESOLVED**, that the Borough Council of Manville Borough, County of Somerset and the State of New Jersey awards a contract for CDBG Funded Manville Library Improvements (Circulation Desk) to R. P. L. Electrical Contractors LLC of Manville NJ in the amount of \$4,250.00.

**BE IT FURTHER RESOLVED** that the Chief Financial Officer of the Borough has certified the availability of funds in the amount of \$4,250.00 for CDBG Funded Manville Library Improvements (Circulation Desk) in grant account 01-201-20-100-253, Equip. Equip. Maintenance.
