**A Resolution By The Mayor & Council Of The Borough Of Manville  
Authorizing The Appointment Of A Part-Time Code Enforcement (Housing &  
Property Maintenance) Inspector**

**WHEREAS**, the need exists within the Borough of Manville for one appointment of a part-time Code Enforcement (Housing & Property Maintenance) Inspector; and

**WHEREAS**, after interviewing and screening, the Mayor, Policy, Planning, and Personnel Committee of the Council, and Borough Administrator have recommended that Dominick Quagliata be appointed to the position of Part-Time Code Enforcement (Housing & Property Maintenance) Inspector; and


**WHEREAS**, the Mayor and Council agree that said appointment is in the best interest of the Borough of Manville,

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Council of the Borough of Manville, County of Somerset, and State of New Jersey, as follows:

- (1) Dominick Quagliata is hereby appointed to the position of Code Enforcement (Housing & Property Maintenance) Inspector, effective September 16, 2024 at the initial annual salary of \$27.00 per hour, for up to 20 hours per week.
- (2) The terms and conditions of Dominick Qualiata's employment shall be in accord with State law and as set forth in Ordinance #2023-1289 & 2024-1319, the Memorandum of Employment and the Manville Borough Personnel Policies and Procedures Manual.
- (3) The Mayor is hereby authorized to sign and execute said Memorandum of Employment on behalf of the Borough.
- (4) This Resolution shall be construed in accordance with the Ordinances of the Borough of Manville, the Laws of the State of New Jersey, and the Laws of the United States. This Resolution shall take effect immediately upon enactment of same.
