Ordinance # 2024-1322

**An Ordinance Amending Schedule I of the Ordinance No. 500
Known as the Traffic Ordinance, As Amended**

Statement of Purpose

The purpose of this ordinance is to restrict parking on North 5th and North 7th Avenues.

BE IT ORDAINED by the Mayor and Council of the Borough of Manville, County of Somerset, State of New Jersey as follows:

Section 1. AMENDMENT OF SCHEDULE I – NO PARKING

Schedule I of Ordinance No. 500 is hereby amended to include the following under the stated designations:

<u>Name of Street</u>	<u>Sides</u>	<u>Location</u>
North 5 th Avenue	West	Beginning 278 feet north of the northerly curb line of Brooks Boulevard and extending 15 feet in a northerly direction
North 7 th Avenue	East	From the northerly curb line of Brooks Boulevard to a point 97 feet north

SECTION 2. INCONSISTENCY

Should any provision of this ordinance be inconsistent with the provisions of any prior ordinances, the inconsistent provisions of said prior ordinances are hereby repealed, but only to the extent of such inconsistencies.

SECTION 3. SEVERABILITY

In the event that any provision of this ordinance, or the application of thereof to any person or circumstance is declared invalid by a court of competent jurisdiction, such declaration of invalidity shall not affect any other provision or application of this ordinance which may be given effect, and, to realize this intent, the provisions and application of this ordinance are declared to be severable.

SECTION 4. PURPOSE OF CAPTIONS

Captions contained in this ordinance have been inserted only for the purpose of facilitation reference to the various section, and are not intended and shall not be utilized to construe the intent and meaning of the text of any section.

SECTION 5. EFFECTIVE DATE

This ordinance shall be effective immediately upon final adoption, approval, and publication in accordance with law.
