**Approve Person to Person and Place to Place -Expansion of Premise Transfer of Liquor  
License 1811-33-023-006 Social 101 L.L.C.**

**WHEREAS**, an application has been filed for a person-to-person transfer of a Plenary Retail Consumption License 1811-33-023-006, heretofore issued to Boulderdash, L.L.C. for premises located at 101 South Main Street; and

**WHEREAS**, an application has been filed for a place-to -place transfer of Plenary Retail Consumption License 1811-33-023-006, for the purpose of expanding the premise under license wherein the sale, service and storage of alcoholic beverages are authorized; and

**WHEREAS**, the submitted application form is complete in all respects, the transfer fees have been paid, and the license has been properly renewed for the current license term; and


**WHEREAS**, the applicant is qualified to be licensed according to all standards established by Title 33 of the New Jersey Statutes, regulations promulgated thereunder, as well as pertinent local ordinances and conditions consistent with Title 33; and

**WHEREAS**, the applicant has disclosed and the issuing authority reviewed the source of all funds used in the purchase of the license and the license business and all additional financing obtained in connection with the licensed business; and

**NOW, THEREFORE, BE IT RESOLVED**, that the Mayor and Council of the Borough of Manville, County of Somerset, and State of New Jersey, does hereby approve, effective November 12, 2024, the person-to-person transfer and expansion of the aforesaid Plenary Retail Consumption License to Social 101 L.L.C. with the licensed premise located at 101 South Main Street to place under license the area delineated in the application form and the sketch of the licensed premise attached thereto, and does hereby direct the Municipal Clerk to endorse the license certificate to the new ownership as follows: "This license, subject to all its terms and conditions, is hereby transferred to Social 101 L.L.C., effective November 12, 2024.
