**RE: AUTHORIZING SUBMISSION OF A GRANT APPLICATION TO THE NEW JERSEY
DEPARTMENT OF COMMUNITY AFFAIRS' DIVISION OF LOCAL GOVERNMENT SERVICES
FOR GRANT FUNDING TO ACQUIRE NEW FIRE DEPARTMENT RADIOS**

WHEREAS, the Borough of Manville seeks to apply for a grant from the New Jersey Department of Community Affairs, Division of Local Government Services, for funding in the amount of \$100,000 to acquire new radio equipment for the Manville Fire Department; and

WHEREAS, the purpose of the grant is to provide the Manville Fire Department with critical communications equipment to enhance operational efficiency, ensure timely response to emergencies, and improve coordination with other emergency services; and

WHEREAS, the Borough of Manville is committed to ensuring the safety and security of its residents, visitors, and transient population by equipping its fire department with the necessary tools to meet the increasing demands of public safety;

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Manville, County of Somerset, State of New Jersey, as follows:

1. The Borough of Manville is hereby authorized to submit a grant application to the New Jersey Department of Community Affairs, Division of Local Government Services, for funding to acquire new fire department radio equipment.
2. The Borough acknowledges and accepts that the Department may offer an award amount different from the requested \$100,000 and, upon receipt of the grant agreement from the New Jersey Department of Community Affairs, the Borough of Manville does further authorize the execution of said agreement, and upon execution, authorizes the expenditure of funds pursuant to the terms and conditions set forth therein.
3. The Mayor, Fire Chief, or other designated officials are hereby authorized to execute the application, grant agreement, and any other documents necessary in connection with the application and subsequent award.

This resolution shall take effect immediately, and a certified copy shall be forwarded to the New Jersey Department of Community Affairs, Division of Local Government Services.
