**AUTHORIZING PURCHASE OF TYPHOON 95' REAR MOUNT PLATFORM**  
**THROUGH THE SOURCEWELL COOPERATIVE PRICING COUNCIL**

**WHEREAS**, Exemptions from competitive bidding are allowed for items/services purchased through a New Jersey State CO-OP per N.J.S.A. 40A:11-11; and

**WHEREAS**, Sourcewell CO-OP awarded contract #113021-RVG-1 to Rev Group, Inc. of Brookfield, WI, the maker of E-ONE brand fire apparatus; and

**WHEREAS**, Absolute Fire Protection Co. Inc, of South Plainfield, NJ is an authorized dealership for E-ONE and has provided the Borough of Manville with a quote under the Sourcewell CO-OP contract #113021-RVG-1 for the purchase of a Typhoon 95' Rear Mount Platform for \$1,822,247.00.

**WHEREAS**, the Borough of Manville is desirous to utilize this contract and vendor pursuant to NJSA 40A:11-12 and NJAC 5:34-7.29 for the purchase

**NOW, THEREFORE, BE IT RESOLVED** by the Borough Council of Manville Borough awards a contract to Absolute Fire Protection Co. Inc of South Plainfield NJ under the Sourcewell CO-OP contract # 113021-RV-1 for the purchase of a Typhoon 95' Rear Mount Platform for \$1,822,247.00.
