**Resolution #2025-36**

**Authorizing Professional Services Agreement  
with Thaddeus R. Maciag Esq. of Maciag Law, LLC  
as Borough Attorney, through December 31, 2025**

**WHEREAS**, the governing body of the Borough of Manville appointed Thaddeus R. Maciag Esq., of Maciag Law LLC, as Borough Attorney, at its January 4, 2025 Meeting; and

**WHEREAS**, the Local Public Contracts Law (N.J.S.A. 40A:11-1, et seq.) requires that the resolution authorizing the award of contracts for “professional services” without competitive bids on the contract itself must be available for public inspection; and

**WHEREAS**, the governing body, upon review of qualifications, determined that Thaddeus R. Maciag Esq. has the necessary qualifications to perform the duties of Borough Attorney, and has provided the Borough with a satisfactory proposal; and

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Council of the Borough of Manville, County of Somerset, State of New Jersey, as follows:

1) The proposed Professional Services Agreement from Thaddeus R. Maciag Esq. of Maciag Law LLC, for the period January 31, 2025 through December 31, 2025 in the form provided and incorporated herein by reference, is accepted.

2) This contract is awarded without competitive bidding as a “Professional Service” in accordance with N.J.S.A 40:11-5(1)(a) of the Local Public Contracts Law;

3) The Mayor, Borough Chief Financial Officer, or Borough Administrator are hereby authorized to execute the proposed Professional Services Agreement for this time period, as consistent with the terms of this Resolution, and, without further resolution of the governing body,

not to exceed \$15,000 for Trial & Appellate Litigation services, and as not to exceed \$99,600.00 for Borough Attorney Services.

4) A Notice of award of this contract shall be published once, in accord with N.J.S.A §40:11-5(1)(a)(I).

5) The Chief Financial Officer shall provide a Certification of Funds.
