**Authorizing Professional Services Agreement with
Cleighton D. Smith, P.E., C.F.M., of Taylor Wiseman & Taylor
as (1) Floodplain Management Consultant;
(2) Flood CRS Consultant; and
(3) Flood Hazard Mitigation Consultant,
through December 31, 2025**

WHEREAS, the governing body of the Borough of Manville appointed Cleighton D. Smith, P.E., C.F.M., of Taylor Wiseman & Taylor as (1) Floodplain Management Consultant; (2) Flood CRS Consultant; and (3) Flood Hazard Mitigation Consultant, for the year 2025, at its January 4, 2025 Meeting; and

WHEREAS, the Local Public Contracts Law (N.J.S.A. 40A:11-1, et seq.) requires that the resolution authorizing the award of contracts for “professional services” without competitive bids on the contract itself must be available for public inspection; and

WHEREAS, the governing body, upon review of qualifications, determined that Cleighton D. Smith, P.E., C.F.M., has the necessary qualifications to perform the duties of Labor Attorney, and has provided the Borough with a satisfactory proposal; and

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Manville, County of Somerset, State of New Jersey, as follows:

1) The proposed Professional Services Agreement from Cleighton D. Smith, P.E., C.F.M., of Taylor Wiseman & Taylor as (1) Floodplain Management Consultant; (2) Flood CRS Consultant; and (3) Flood Hazard Mitigation Consultant, for the period January 1, 2025

through December 31, 2025, in the form provided and incorporated herein by reference, is accepted and approved.

2) This contract is awarded without competitive bidding as a "Professional Service" in accordance with N.J.S.A 40:11-5(1)(a) of the Local Public Contracts Law;

3) The Mayor, Borough Chief Financial Officer, or Borough Administrator are hereby authorized to execute the proposed Professional Services Agreement, as consistent with the terms of this Resolution, and, without further resolution of the governing body, not to exceed \$83,000.00.

4) A Notice of award of this contract shall be published once, in accord with N.J.S.A §40:11-5(1)(a)(I).

5) The Chief Financial Officer shall provide a Certification of Funds.
