**Authorizing Professional Services Agreement**

**with Joseph A. Brosnan, PE, PP, CME, Van Cleef Engineering Associates LLC,  
as Borough Engineer, through December 31, 2027**

**WHEREAS**, the governing body of the Borough of Manville at its January 4, 2025 Meeting appointed Joseph A. Brosnan, PE, PP, CME, Van Cleef Engineering Associates LLC, as Borough Engineer to a three-year term of office as set forth in N.J.S.A. §40A:9-140, through December 31, 2027; and

**WHEREAS**, this Resolution awarding a contract for said appointment shall be made available for public inspection; and

**WHEREAS**, the governing body, upon review of qualifications, determined that Joseph A. Brosnan, PE, PP, CME, Van Cleef Engineering Associates LLC, has the necessary qualifications to perform the duties of Borough Engineer in accord with N.J.S.A. §40A:9-140, and has provided the Borough with a satisfactory proposal; and

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Council of the Borough of Manville, County of Somerset, State of New Jersey, as follows:

1) The proposed Professional Services Agreement from Joseph A. Brosnan, PE, PP, CME, Van Cleef Engineering Associates LLC, as Borough Engineer for the three-year term of office set forth in N.J.S.A. §40A:9-140, in the form provided and incorporated herein by reference, is accepted and approved.

2) This contract is awarded without competitive bidding as a "Professional Service" in accordance with N.J.S.A. §40A:9-140 and N.J.S.A §40:11-5(1)(a);



5) The Chief Financial Officer shall provide a Certification of Funds.
