**Authorization for Temporary Road Closure- Christ the Redeemer Parish Events**

**WHEREAS**, Christ the Redeemer Parish hosts annual religious events to celebrate their faith; and

**WHEREAS**, Christ the Redeemer Parish, in a letter dated Jan. 9, 2025, has requested the use of Borough streets for these events; and

**WHEREAS**, the Manville Police Department and the Manville Office of Emergency Management have reviewed the requests and have no objections; and

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Council of the Borough of Manville, County of Somerset, State of New Jersey authorizes the following use of Borough streets and temporary road closures:

April 1, 2025, 6 p.m. – Stations of the Cross Procession, Start Christ the King Church, across Brooks Blvd., 3<sup>rd</sup> Ave. to North St. to N 13<sup>th</sup> Ave., to Washington Ave., to S 3<sup>rd</sup> Ave, to Filak Street ending at Sacred Heart Church

April 19 - April 20, 2 p.m. - Holy Week Procession, close Filak Street in front of the church

May 3, 2025, 9 a.m. to 1 p.m. - First Communion Celebration, close Filak St. in front of Sacred Heart Church.

June 22, 2025 9 a.m. to 11 a.m. – Corpus Christi Procession, Begin at Sacred Heart Church on Filak St. to S. Main St. to Brooks Blvd. to Christ the King Church

June 27, 2025 6:30 p.m. to 7:30 p.m. – Feast of Our Lady of Perpetual Help Procession, Begin at Sacred Heart Church to S. 3<sup>rd</sup> Ave. to Washington Ave. to S. 2<sup>nd</sup> Ave. to Filak St.
